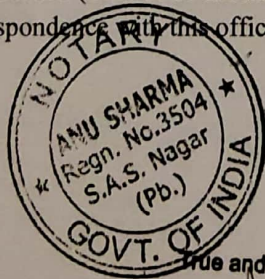
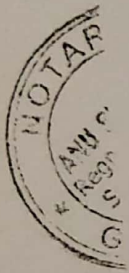



- 9) For the children mentioned in Para No. 7, Section 12, sub section 2 of Act all expenses of the school will be recovered. For the acceptance of this recovery school will have to open the separate bank account.
- 10) School will not charge any capitation fees and will not indulge the children or his parents or his guardian in any selection process.
- 11) School will not neglect to any children because of below given reasons:-
 - A) If there is no proof of any children's date of birth.
 - B) If children make any demand for admission within extended period or after the extended period.
 - C) Religion, Caste or place of birth or any of this.
- 12) School will make sure that:-
 - A) Class will not be repeated once a admission given to any children or School will be restigate to any children till he is not complete his primary education.
 - B) No physical punishment or mental-harassment will be given to any children.
 - C) Till the completion of Primary Education of the children there is no need to complete any kind of board examination.
 - D) A Certificate will be provided to every children who have completed his primary education under rule 21.
 - E) As per sub section of the Act Paralised/ special needed children will be indulge.
 - F) As per Sub Rule (1) of Section 23 of the Act only that kind of teachers will be appointed who have minimum educational qualification.
 - G) Teachers can't indulge in any kind of private coaching.
- 13) Teacher will accept the syllabus as per prescribed subjects provided by the authority of the school.
- 14) School will obey the conditions under Section 19 of the school Act.
- 15) School can't run any other non approved classes inside or outside the school premises, in the name of this school.
